Wedding \$400 bond minimum (larger weddings will attract a larger bond)

Party \$200 bond minimum (larger parties will attract a larger bond)

All damage caused to venue by a booking will be the liability of the hirer

Payment Terms

50% deposit plus bond required to hold your booking

50% balance to be paid 4 weeks prior to booking

*Any bookings made within this 4 week period will require 100% payment in advance

This Event Booking Form initiates your request to hire the club facilities and records your commitment to be bound by these Terms and Conditions.

To book and confirm your event please complete these steps:

- 1. The Function Manager will advise you if this date is available via email.
- 2. Your booking will be entered into the system and an email ONLY will confirm the availability of the venue.
- 3. If the date is available and your booking request accepted, your will receive an invoice for the hire amount.
- 4. A deposit of 50% plus applicable bond (Found above) is due to accept your booking.
- 5. An email from the club will be provided once your deposit has been paid and your booking accepted.
- 6. A 50% balance payment of your booking hire fees are required to be paid 4 weeks prior to the booking date of the event to complete the booking.
- 7. If you do not make a payment on time your booking may be released and no refund provided.
- 8. All payments should be made electronically into the club's Function Account. The details of the deposit can be found on the invoice. Please reference your surname and booking date when making the deposit.
- 9. Please note, cancellations of bookings are non-refundable.

Vacating the premises: At the conclusion of your function there is a half hour period prior to your nominated end time when last drinks are served, music is turned off and lights on. It is during this half an hour where all your guests must vacate the premises or additional costs will be incurred. All personal belongings (including any remaining beverages) must be removed at this time. No responsibility will be taken by the venue should items be left behind.

Austinmer SLSC Function Centre does NOT supply any alcohol or any other beverages. These must all be provided by the hirer. (Please note, there are no keg facilities at the Surf Club – all beer must be bottles or cans.)
